Memopark serves as a reference partner for operators seeking to **rethink children's entertainment from a strategic perspective**, creating long-term value through coherent and memorable experiences.

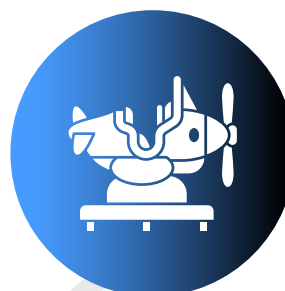

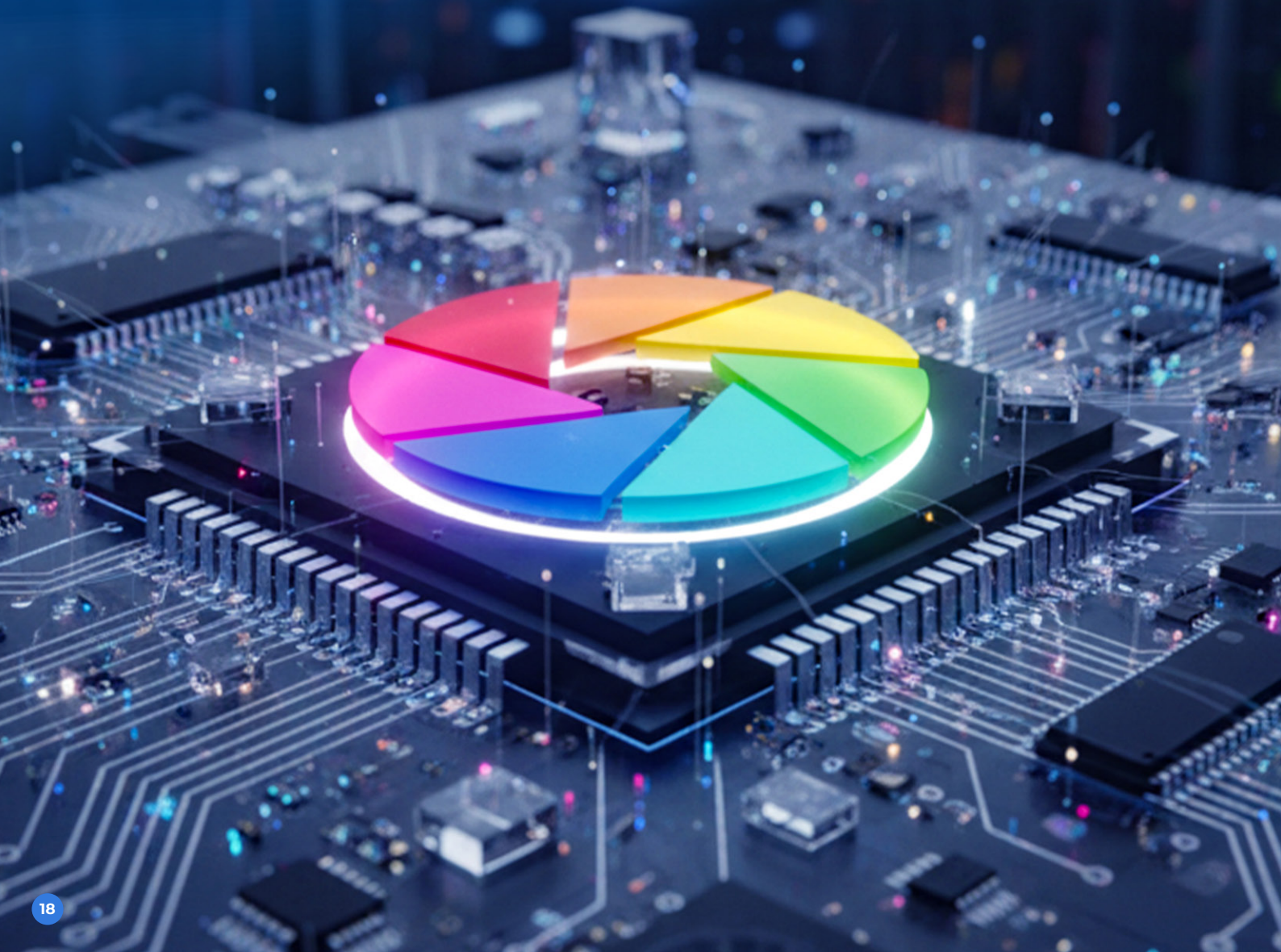

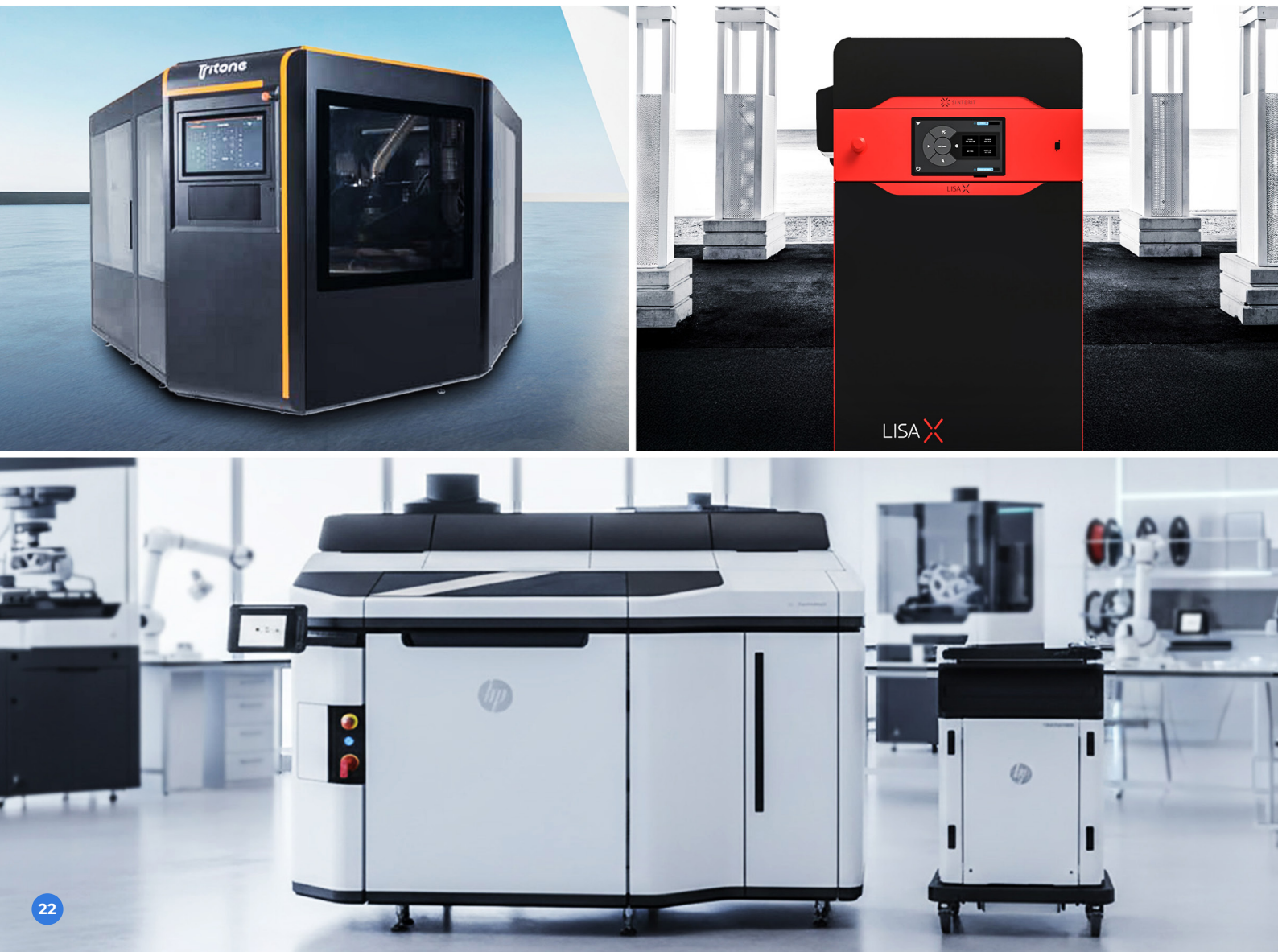
